The contempt petitions have been filed for non-compliance of the directions contained in the common order dated 09.09.2024 passed by this Court in W.A.Nos.1076, 1074, 1071, 1072, 1073, 1066, 1065, 1075, 1069 and 1068 of 2024.

Heard on I.A.Nos.1 of 2024 in C.C.Nos.2221, 2222, 2223, 2224, 2225, 2226, 2227, 2228, 2229 and 2230 of 2024.

Learned counsel for the petitioners submit that in C.C.Nos.2046, 2047, 2049 and 2062 of 2024, this Court had passed an interim order on 21.10.2024. It is further submitted that the last date of admission to professional courses is 23.10.2024. It is therefore submitted that similar interim order be passed in these interlocutory applications as well.

For the reasons assigned by us in the order dated 21.10.2024 passed in C.C.Nos.2046, 2047, 2049 and 2062 of 2024, petitioners are permitted to fill up the seats which are lying vacant on account of the increased intake capacity approved by All India Council for Technical Education (AICTE) subject to the condition that the petitioners shall not charge any capitation fee from the students.

Let the contempt cases be listed for further orders along with C.C.Nos.2046, 2047, 2049 and 2062 of 2024.
