AND WHEREAS on the said representations of the First Party, the Second Party has accepted the offer of the First Party and agreed to permit the First Party to supply food and Beverages on the terms and conditions mutually discussed, agreed upon and recorded hereunder:

TERMS AND CONDITIONS:

- 1. This Agreement shall remain effective for two (2) year's for the present and shall terminate automatically after TWO year from the date of its execution. The term of this agreement during its tenure may be revised from time to time according to the necessity that may crop up during progress of the contract by mutual consent. If any of the parties' wats to terminate the agreement during the tenure, it must give a notice of at least Three (3) months. This agreement may be renewed after TWO year, if required with suitable modifications on mutual discussions and consent.
- That the First Party awards the contract to set up facilities to provide food, beverages and snacks to the students, employees, clients, guests of the Second Party. That to enable the First Party to offer the services, in terms of this agreement, the Second Party agrees to provide the following:
- The first party has agreed to obtain on rest of the said premises from landlord on a monthly rent of 40000/- {rupees Forty thousand only) towards the monthly rent payable on or before 10" every English Callender month.

An appropriate space as shown & agreed in side the premises to install the equipment required; Electricity connection with power back-up;

Water Supply.

- That to provide the services, as envisaged under this Agreement, the First Party shall be free to install all the Kitchen operating supplies including crockery, this shall be maintained by the First Party.
- 5. The Menu prices shall be fixed by the principal of the Institute of Aeronautical Engineering. The prices will display after duly signed by the principal.

Repairs & Maintenance:

- 1. Branding, Cleaning, Garbage lifting will be taken care of by First Party.
- 2. Electricity Bill will be paid by First Party.
- 3. Minor Repairs like Electrical repairs and Lights replacements will be taken care of by First Party.
- 4. Major Repairs need to be taken care of by Second party.
