The system includes, but not limited to, a processing system in a computer network that includes at least one hardware processor, the processing system configured to perform: providing, memory management services through paging while the data messages are forwarding to the networking layer; providing, a lookup map with a set of header fields for the data message to a particular identifier with its paging segment corresponding to a particular service that sends the data messages; and providing, a memory management of multiple pages, storing in a computer memory a selection indicating a memory object for the forwarded data messages and memory management policies for the memory object and managing the memory object for the forwarded data messages according to the stored selection; and managing the pages according to the selections in the lookup map. Claims:We Claim:

- 1. A system for managing pages in a logical network gateway, comprising:
- a processing system in a computer network that includes at least one hardware processor, the processing system configured to perform:
- providing, memory management services through paging while the data messages are forwarding to the networking layer; providing, a lookup map with a set of header fields for the data message to a particular identifier with its paging segment corresponding to a particular service that sends the data messages:
- providing, a memory management of multiple pages, storing in a computer memory a selection indicating a memory object for the forwarded data messages and memory management policies for the memory object and managing the memory object for the forwarded data messages according to the stored selection; and managing the pages according to the selections in the lookup map.
- 2. The system as claimed in claim 1, wherein each identifier corresponding to a different service and associated with a separate dynamically-updated data structure comprising instructions for forwarding data messages to the corresponding service.
- 3. The system as claimed in claim 1, wherein a specific dynamically-updated data structure associated with the each identifier and memory management policies to retrieve instructions for forwarding data messages to the specialized service, and forwarding the data message according to the retrieved instructions from the particular data structure associated with the particular identifier.
- 4 __The system as claimed in claim 1. wherein the logical network gateway comprises logical switches to which the logical network endpoints connect and a logical router

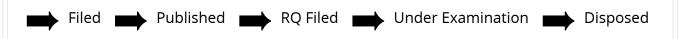
